

The relevance of feminism in promoting gender reform in the context of progressive Islam

Abstract

Abstrak

Encouraging women's economic empowerment is an important step in gender reform. This includes providing access to credit, skills training, and support for women-owned micro and small businesses.

Changes in political culture and leadership dynamics have played a crucial role in supporting the gender reform process. When women are actively involved in the political sphere, this not only becomes important but also encourages the importance of women's quotas in political institutions to ensure more equitable representation. However, it should be understood that women's participation in politics should not be considered an end in itself but rather a tool to achieve broader changes in the structure of society. Fighting for gender equality relies on women's involvement in the political sphere and recognizes its potential positive impact on forming a more inclusive, fair and equal society.

Rolling out gender reform is a collective struggle that requires continuity and long-term commitment to achieve meaningful change in society, especially in the context of Muslim societies. In addition to ensuring women's involvement in the political sphere, it is important to recognize that this agenda relies on changes in social norms, attitudes and practices beyond the formal political framework. In this regard, recognizing the strategic role of women's political participation is an important foundation in realizing a holistic transformation towards broader gender equality. Reforms aimed at leveling the political stage for women are an integral part of the process toward a society based on universal values of inclusivity, justice and equality.

CONCLUSION

An increasingly inclusive and progressive understanding of Islamic teachings has paved the way for more just and equitable social change. Clear evidence of the positive impact of the feminist movement in progressive Islam is manifested in the transformation of social norms and increased awareness of women's rights. Although challenges such as resistance from conservative groups are still a real thing, the huge potential for gender reform in Muslim societies remains wide open. Creating a more inclusive, equitable, and equal society in the future requires the active involvement of women, youth, religious leaders, and all walks of life in a collaborative effort. However, it is important to note that the limitations of this study lie in the limited scope of the literature analysis and the focus on certain aspects of the feminist movement in Islam. Therefore, there is room for more in-depth and detailed research, and cross-sector cooperation is crucial in building a holistic approach to stimulate broader and sustainable positive change in the struggle for gender equality in the context of progressive Islam.
